COMMENTS FROM THE PUBLIC ON PROPOSED RESOLUTIONS:

Mrs. Lipstein stated P-2 I did want to make an inquiry about the Interim Superintendent Roland Bolandi — what his position was because that was sort of vague — there wasn't enough information on there. My concern about interim superintendent is that it didn't give enough information and of course I researched and looked him up and he does have a lot of experience and he has some interesting comments he has made about Montclair and I think that going out and getting experience from people who work in similar districts (inaudible) I think it is a fabulous idea. My concern was it just wasn't enough

identifying information on that so I'm very glad you have that. It is probably a good thing for our other administrators.

Mr. Arminio stated why is it even a resolution? Mr. Damato stated the State Board requires that we adopt a resolution approving the mentorship.
